# FROM CONGRESSWOMAN HALEY STEVENS

Dear Friend,

It was another consequential year for Michigan's 11th Congressional District. Throughout 2025, working families have felt the pain from higher grocery bills, rising health care costs, and the gutting of vital research and science that protects our communities. These are real challenges, and I've spent this year fighting every day to address them.

I worked to ease the burdens Michiganders face at the checkout line with the *No Tariffs on Groceries Act* and I fought to protect our workers and create good-paying jobs with the *Union Auto Workers Job Protection Act*. I also pushed to reduce our dependence on China and make it clear that Michigan workers should not shoulder the costs of broken trade policies. My *Unearth America's Future Act* would bring our critical mineral supply chains back home, lower costs, create jobs, and, as always, keep Michigan at the center of American manufacturing.

But protecting our families isn't just about economics—it's also about accountability and safety. That's why I introduced the *Stop Trump's Abuse of Power Act*, to make sure no president is above the law and that Trump cannot use the military to further his personal agenda. And as always, I stood up for science and public health by introducing Articles of Impeachment against Robert F. Kennedy, Jr. No public official should be making decisions that endanger Michiganders' health and safety.

My record of delivering real results is why I'm honored to have been recognized by the Center for Effective Lawmaking as the most effective Democratic lawmaker from Michigan. But the work continues!

This year has reminded me that listening, learning, and taking action aren't just words—they're the work of representing Michigan families every single day. Together, we were able to put more than \$13,264,000 back into Michiganders' pockets.

As always, the best part of my job is meeting with Michiganders. # Constituent Service Highlights

"I recently reached out to the office of Representative Haley Stevens and had the pleasure of connecting with a member of her staff. I come from a family that suffered great losses at the hands of the Nazis in World War II. I had a cousin whose brother enlisted in the Navy and served in the Pacific theater. He never returned and the particulars of his death were not clearly elucidated. I set out on a mission to uncover details about my cousin knowing only his name, position, and rank within the U.S. Navy. I called so many phone numbers seeking help with my journey that I lost count. I resigned myself to knowing his story of sacrifice and untimely passing would be told. I wondered whether my U.S. Representative and staff might be of some help. I called the office and shared my profound frustration and they showed incredible empathy. In short order, her staff unearthed a trove of information on my cousin. In my mind, his service and tragic death can now be more fully recognized and his memory shared as a blessing. I would not have had the opportunity to honor his memory this way without the work of her staff."



# 2025 Legislative Highlights

## In 2025, Rep. Haley Stevens:

- **Introduced dozens of new pieces of legislation** to lower costs and fight for Michiganders.
- **Passed her *Department of Energy and National Science Foundation Interagency Research Act* through the House.**
  - The bill would strengthen coordination between the two federal agencies to advance the future of scientific innovation.
- **Passed her *Post Quantum Cybersecurity Standards Act* through the House Science Committee.**
- **Fought back against** the Trump Administration's attacks on science, public safety, and health care.
- Drew national attention to the entry of **corporate greed** in college sports.



# **2025 Legislative Highlights**

## **1. No Tariffs on Groceries Act**

This bill would lower grocery costs by preventing the president from unilaterally imposing tariffs on food and agricultural products.

## **2. UNEARTH America's Future Act**

This bill strengthens U.S. critical mineral supply chains for national security, economic competitiveness, manufacturing, and clean energy.

## **3. No Chinese Cars Act**

This bill cracks down on the Chinese Communist Party's unfair trade practices and stands up for American automakers, potentially bringing new jobs to Michigan and strengthen America's auto industry.

## **4. Stop RFK's Bad Science Act & Articles of Impeachment Against Secretary Robert F. Kennedy, Jr.**

When RFK Jr. cut lifesaving research, Stevens couldn't sit by and do nothing. She had to act. She introduced a bill to reverse RFK Jr.'s devastating cuts.

When he doubled down and continued to cut research, particularly childhood cancer research, she called on him to resign. When he continued to uplift quack science and spread new conspiracies about Tylenol, she was left with no choice but to call for impeachment.

RFK Jr. is making our country less safe. He must be impeached and removed from office.

# Key Congressional Oversight Efforts

- Rep. Stevens warned the Big Ten Conference that its reported plan to sell a 10% stake in its media rights for \$2.4 billion **risks putting corporate profits ahead of student-athletes, college sports, and university integrity.**
  - Giving private investors control over a major source of university revenue could threaten university independence, non-revenue-driven sports, and Title IX athletic programs.
  - Stevens also warned that this deal would **open the door to private equity** in college sports, potentially leading to further conference realignment chaos and creating a race-to-the-bottom that hurts fans and athletes.
- Rep. Stevens called on the National Science Board to **stop the ongoing destruction of the National Science Foundation (NSF).**
- Rep. Stevens raised the alarm about **Elon Musk's illegal mass firings** and their impact on the Great Lakes Environmental Research Laboratory (GLERL).
  - The GLERL was the only NOAA facility in the Great Lakes region focused on critical research to protect the lakes' health.
- Rep. Stevens raised urgent concerns to Secretary Kristi Noem about **the Homeland Security Department's diminished focus on preventing domestic terrorism.**
  - Stevens' letter followed reports that a division of DHS drastically scaled back its focus on countering violent extremism and is being led by someone with limited professional experience in counterterrorism or homeland security.
